**Regarding: Latvian parliament's vote to withdraw from the Istanbul Convention**

*(Council of Europe Convention on preventing and combating violence against women and domestic violence)*

Dear President Rinkēvičs, Prime Minister Siliņa, Aivars Lembergs- leader of ZZS, Ainars Šlesers- leader of LPV, Linda Liepina- member of LPV party, Mr. Vilis Krisopansvilis- Member LPV party, European Parliament,

Women's Declaration International (WDI)\* is writing to you to offer feedback to Latvia's potential withdrawal from the [Istanbul Convention](#) (Council of Europe Convention on preventing and combating violence against women and domestic violence). Women's Declaration International supports the Istanbul Convention. We are an international, female-only organisation, consisting of volunteer women from across the globe dedicated to protecting women's **sex-based** rights. Women's Declaration International works in particular for the elimination of all forms of discrimination against women and girls that result from the replacement of the Category of sex with that of 'gender identity'. Women's Declaration International encourages governments and international institutions to ensure that use of the words *woman* and *girl* be returned to the age-old understanding of the terms, linked solely to **biological sex**. Any use of the word '**gender**', for example in describing stereotypical roles, behaviours, or one's physical presentation, is based on material reality in that two sexes and only two sexes exist. Ideally, the word **gender**, which has in recent years increasingly become nonsensical, progressively falls out of usage.

WDI has learned that Latvia's Union of Greens and Farmers (ZZS) recently circulated a statement that the Ministry of Culture and the Ministry of Education and Science had violated the Istanbul Convention by using it for other purposes: to promote a different understanding of gender, "reinforcing gender ideology" in Latvia. It is this latter aspect of the debate in Latvia which has incited WDI to contact you. We share the above-mentioned concern of the Union of Greens and Farmers (ZZS).

Women's Declaration International encourages all signatories of the Istanbul Convention to lobby for modifications to the document, in essence, to save it. The Istanbul Declaration causes confusion through promoting the concept of **gender identity** which in itself has no connection to the defense of women and girls and therefore, any reference to **gender identity** (ex. article 4.3) should be removed. Ideally, removal of all use of the word **gender** in the Istanbul Declaration is recommended. Satisfactory linguistic modifications could transform this valuable Convention, making it acceptable to all Latvian political parties, and in addition, such linguistic modifications could motivate European countries (and beyond) that have not yet ratified it, to do so. This is potentially a critical moment in both Latvian, EU and international history. Latvia could be the EU country able to make a major and positive impact and indeed to alter the EU's future, in defense of women and girls. Latvia could help to straighten the course of the ocean liner 'EU', sorely in need of radically improved navigation in all things related to women and girls. Please help Latvia be that country.

Kindly see below several examples of specific wording in the Istanbul Declaration which today actually cause prejudice toward women and girls, due to the ever-evolving inaccuracy regarding current use of terms *woman*, *girl* and *gender*. Please see the related suggestions below, from WDI, for possible amendments to the Istanbul Declaration in the interest of linguistic clarity in relation to defending the rights of women and girls. (*n.b. An appendix has also been added to further address the issue of contemporary language use and to provide sources of discussion re. gender identity.*)

In closing, President Rinkēvičs, Prime Minister Siliņa, Mr. Lembergs, Mr. Šlesers, Ms. Liepina, Mr. Krisopansvilis, please accept this communication from Women's Declaration International\*, written in good faith, requesting you to continue the debate about the Istanbul Convention and requesting you to help your population learn about the increasingly precarious situation of women and girls caused by ideologically motivated linguistic usage in innumerable national, European and international documents which were originally meant to support and protect women and girls, but which have lost their impact due to confusion caused by the ever-changing use of the word **gender**, and by the insertion and generalised use of the term **gender identity**. WDI hopes you can save the Istanbul Convention and render it a document that truly supports the safety and dignity of women and girls.

## **Examples of wording in the Istanbul Declaration which cause prejudice toward women and girls:**

1. WDI (Women's Declaration International) recommends that the use of the word **gender** be removed from the Istanbul Convention. In the definition below, the word **stereotype** is a suitable replacement for 'gender'

### **Article 3c (definitions):**

"**gender**" shall mean the socially constructed roles, behaviours, activities and attributes that a given society considers appropriate for women and men;

2. WDI suggests '**Gender-based violence**' be replaced with '**sex-based violence**'.

### **Article 3d (definitions)**

"**gender-based violence against women**" shall mean violence that is directed against a woman because she is a woman or that affects women disproportionately;

3. WDI suggests the term '**Gender identity**' be eliminated where appropriate from any document pertaining to rights and protection of women, thus reinforcing biological sex as the sole attribute of womanhood.

### **Article 4.3 Fundamental rights, equality and non-discrimination**

The implementation of the provisions of this Convention by the Parties, in particular measures to protect the rights of victims, shall be secured without discrimination on any ground such as sex, gender, race, colour, language, religion, political or other opinion, national or social origin, association with a national minority, property, birth, sexual orientation, **gender identity**, age, state of health, disability, marital status, migrant or refugee status, or other status.

4. Because the use of the term **gender** in the Istanbul Convention does not refer solely to biological sex (female), WDI perceives the entire Article 6 as worthy of deletion, or alternately, that the article title: **Gender-sensitive policies** be replaced with:

### **Biological sex-sensitive policies.**

### **Article 6 – Gender-sensitive policies**

Parties shall undertake to include a gender perspective in the implementation and evaluation of the impact of the provisions of this Convention and to promote and effectively implement policies of equality between women and men and the empowerment of women.

# APPENDIX

**the purpose of this appendix is:**

- 1. to provide sources for further information about the current confusion of the terms *sex* and *gender***

**LANGUAGE** - Use of the word 'gender' in international agreements, conventions, as well as in national and EU legislation, no longer systematically makes the connection to biological sex.
